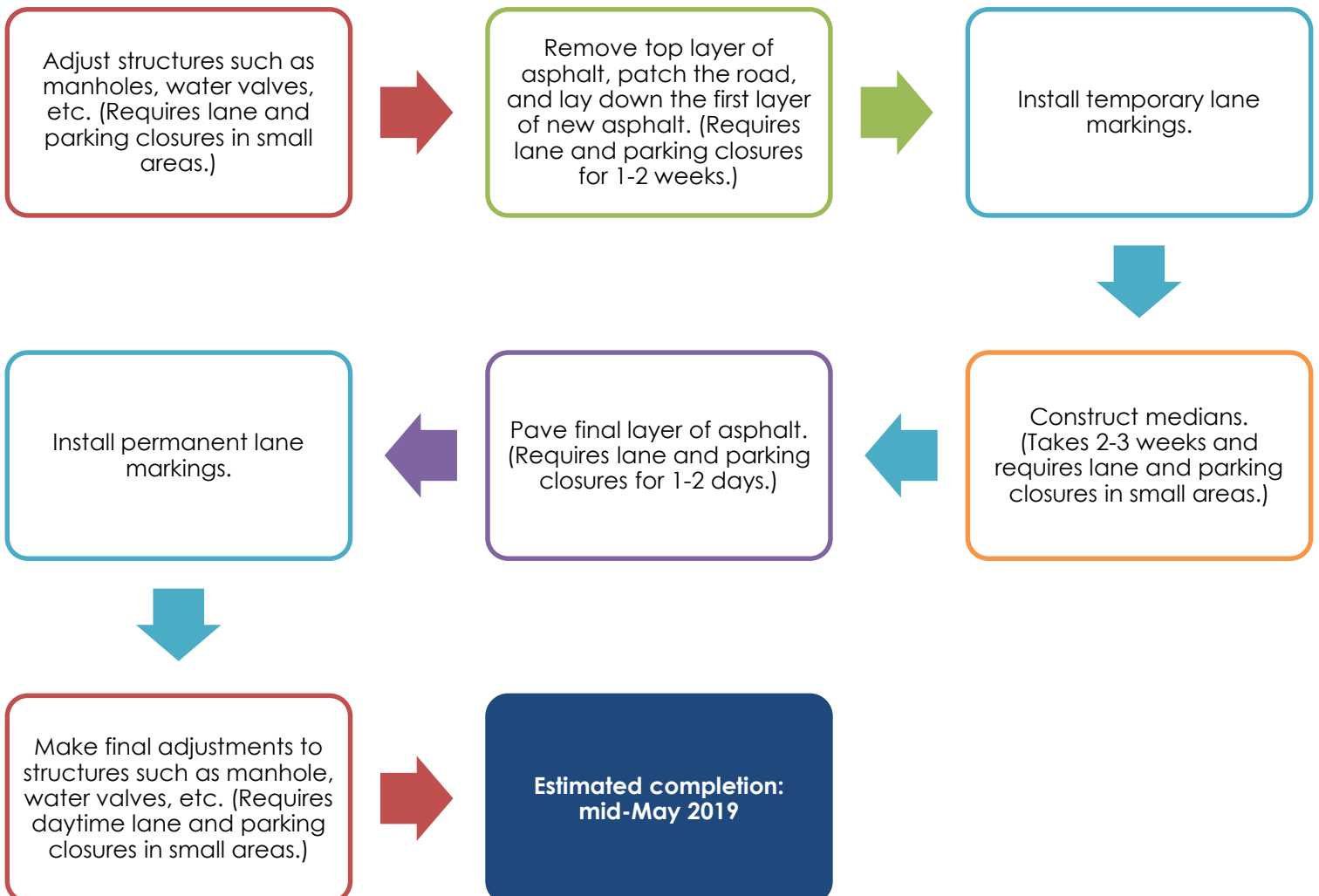


## CONSTRUCTION NOTICE

The City of Bloomington and its contractors will begin extensive work on the following roads in Downtown Bloomington the week of April 1, 2019:

- Front Street, Madison Street to East Street
- Center Street, Washington Street to Front Street
- Main Street, Washington Street to Front Street

Please be aware that on-street parking and driving on these roads will be restricted at various times throughout the project timeline, which is shown below. In addition, the Connect Transit transfer station will move temporarily beginning April 8, 2019. A map of the construction area, public parking, and temporary relocation of the bus transfer station has been included on the back of this page.
